為何我們要求您填寫本表格？

Why are we asking you to complete this form?

為維護稅制完整，全球各地政府現正推出適用於金融 / 財務機構的資料收集及匯報新規則，名為共同匯報標準（簡稱「CRS」）。

根據 CRS 規定，我們必須確定您的「稅務居住地」（這通常是您有義務繳納薪俸稅的國家 / 地區）。若您的稅務居住地有別於所持賬戶的司法管轄區，我們可能需要將此情況及您的有關賬戶資料告知國家稅務機關，該等機關隨後或會將相關資料傳送給不同國家 / 地區的稅務機關。

填妥本表格可確保我們持有您正確及最新的稅務居住地資料。如您的情況有變，導致本表格內的任何資料不再正確，請立即告知我們，並提交一份已更新的自我證明表格。

To help protect the integrity of tax systems, governments around the world are introducing a new information-gathering and reporting requirement for financial institutions. This is known as the Common Reporting Standard (the "CRS").

Under the CRS, we are required to determine where you are a "tax resident" (this will usually be where you are liable to pay income taxes). If you are a tax resident outside the jurisdiction where your account is held, we may need to give the national tax authority this information, along with information relating to your accounts. That may then be shared between different jurisdictions' tax authorities.

Completing this form will ensure that we hold accurate and up to date information about your tax residency.

If your circumstances change and any of the information provided in this form becomes incorrect, please let us know immediately and provide an updated self-certification.

Who should complete the Self-Certification Form – Controlling Person?

如有關大聖證券有限公司賬戶是由被動非財務實體（例如特定信託或投資工具）持有，我們需要對該實體行使控制權的個人填寫本表格。這些個人被稱為「控權人」。

如您需代表實體（包括企業、信託和合夥）作自我證明，請填寫「自我證明表格-實體」（CRS-E）。同樣地，如您是個人客戶或獨資業務客戶，請填寫

「自我證明表格-個人」（CRS-I）。每名控權人須分別填寫一份表格。即使您已就美國政府《外國賬戶稅務合規法案》（簡稱「FATCA」）提供所需的資料，您仍可能需就 CRS 提供額外資料，因為兩者為獨立的規則。

When an account is held with Monmonkey Group Securities Limited on behalf of a Passive NFE (for example certain trusts or investment vehicles), we need those individuals who exercise control of the entity to complete this form. These individuals are termed "Controlling Persons".

If you need to self-certify on behalf of an entity (which includes all businesses, trusts and partnerships), complete a "Self-Certification Form - Entity" (CRS-E). Similarly, if you are an individual customer or a sole trader, complete a "Self-Certification Form - Individual" (CRS-I).

Each controlling person will need to complete a separate form.

Even if you have already provided information in relation to the United States Government's Foreign Account Tax Compliance Act ("FATCA"), you may still need to provide additional information for the CRS as this is a separate regulation.
